**CONSULTATION**

Rate: **\$300/hour**

**ON-SITE INVESTIGATIONS**

Rate: **\$3,000** per day plus travel & lodging expenses

**DEPOSITIONS**

Rate: **\$1,500**: Lifesaving Resources / **\$3,000** other locations

The fee for depositions conducted in my office is \$1,500 for up to 5 hours and \$300 for each additional hour. The fee for depositions conducted outside of my office is \$3,000 per day (not to exceed 10 hours for deposition and travel time) plus travel and lodging expenses. Prior to the taking of my deposition, the opposing attorney must agree to these fees, and payment is due prior to the start of the deposition. Airfare, travel and lodging expenses (if required) must be paid in advance.

**COURT APPEARANCES**

Rate: **\$3,000** per day plus travel and lodging expenses.
